CHAIRMAN'S REVIEW John McArthur

GAP continues to do a great job. I think we all know the loving nature of many greyhounds and the fact that they do make great companions.

This year has been extremely busy. An independent panel was set up to review the welfare and performance of GRNZ. The review has pointed out where we need to improve.

Number one on the list was to appoint a Welfare Officer, introduce some rule changes and adopt a welfare code of practice.

All these steps are in the right direction. It is disappointing that some licence holders and owner trainers continue to resist change. We must all accept that the expectation of society and the public is paramount to our survival as an industry.

GAP continues to do a great job. I think we all know the loving nature of many greyhounds and the fact that they do make great companions, but not all dogs are suitable for adoption. Phil Green has been appointed by the Board to GAP, giving us a direct link. While GAP is a charitable organisation, we continue to heavily fund it - GAP will require an on-going commitment from the industry. While on the area of welfare, we all need to understand that we are not alone in this. The Australian states are addressing the same issues. We must be pro-active in dealing with this important issue.

It is disappointing that a number of our race meetings are not being exported for various reasons. If this was to continue this would not only be a blow to greyhound racing but also the entire racing industry. We continue to build market share within NZ.


The Board will continue its efforts to establish links with Asia through our Vietnam connection, and will explore any other opportunities within Asia as they arise. During the course of the next six months, clubs and licence holders will be receiving a visit from Graeme Nahkies who is to undertake a review of the constitution of GRNZ, and also the clubs' constitutions. During the course of the year at club meetings held by the GRNZ the clubs requested this. It will be a comprehensive review of the constitutions of our clubs and board. I would urge all participants be they licence holders, club officials, or just interested parties - this is your opportunity to have your say.

The board has continued its review of track surfaces by the NZ Sports Turf Institute who have continued this work for us, and we are continuing to collate all the results of the penetrometer readings. They are also continuing their analysis of sands and long term it may be that a different type of sand may be found.

The fitting of safety rails to tracks which require them is now being considered. South Australia has fitted these rails and they appear to give considerable protection to the dogs. Also, padding has been fitted to bends on the tracks where it was required. We will continue to try to be innovative in finding ways to protect our dogs.

Some years ago when the number of dogs being registered in NZ had continued to drop, the then Board took a number of steps to address this issue by the introduction of the NZ Racing Series, breeders incentives, and frozen semen. It's not often that one can say that these were so successful that now we need to review some of these.

To club executives, secretaries and CEO's, I extend my thanks on behalf of the Board for your continued efforts in producing and delivering the races required, and the management of their clubs.

To Jim Leach and staff of the GRNZ, along with my Board I extend our thanks. A small team which works way beyond expectations, you continue to deliver.

To my board, a big thanks for your support during the year.

To outgoing board member John Apanowicz, I thank you for your contribution over your four year term.

I welcome Sean Hannan to the executive.

I wish all participants in the industry all the best for the coming season.

GENERAL MANAGER'S REVIEW Jim Leach

Demands for greater TV coverage of domestic races has made the Australian market more difficult to manage this season.

The 2012/13 racing season has been another successful year in spite of many challenging issues with our export product.

Serious concerns over animal welfare tended to overshadow the significant amount of work that has taken place recently on improving track surfaces and generally improved course safety.

The independent review of animal welfare carried out this season raised 72 points that need to be addressed, and these recommendations have been accepted by the GRNZ Board and will be put in place without delay.

Some of these require rule changes and these will be reviewed at the AGM in October.

Demands for greater TV coverage of domestic races has made the Australian market more difficult to manage this season, and this looks no closer to being resolved in the coming months. The financial benefits from export plays a key role in the sustainability of our industry and therefore considerable resources are being put into encouraging the Racing Board's agents, TAB CORP to keep applying pressure so these avenues stay open or even expand.


In addition to the Australian market, some trial product has been exported to the UK, and we are hopeful that this may grow into a more regular market. Asia, particularly Vietnam is the big opportunity on our doorstep, but obtaining legal access with secure payment is still elusive - we will continue to explore all realistic options. There is no doubt that dog racing has strong appeal to Asian customers, but access issues will not be easy to resolve.

We are still frustrated at government inaction over offshore 'leakage' by some of our major domestic betting customers as technology enables a global choice of betting options. The New Zealand Industry derives no income from this in spite of having to bear the cost of maintaining a viable racing infrastructure.

The activities of the RIU and the JCA were reviewed by an independent consultant this season and the recommendations from that are still being considered. We must remain vigilant and deal decisively with any prohibited substance that is detected in a dog, and with this in mind the number of dogs tested this season is at a record high.

I would like to thank the GRNZ Board for their patience and guidance during the season and the GRNZ and club staff who in the face of natural disasters such as weather and earthquakes keep the races running.







RACING MANAGER'S REVIEW Stuart Cashen

Greyhound Racing had another successful year and looks well placed to build on this for the next season.

Racing

THE 2012/2013 SEASON

With a record stakes pay out this season of over \$11 million an increase of \$1,400,000 on the previous season, strong turnovers, ownership and running a record number of races, greyhound racing had another successful year and looks well placed to build on this for the coming season.

We saw some great racing through the year, not only in the group races but also through a very competitive NZRS series across all grades. The vision of the Board in setting up these races to encourage NZ breeding has been very successful; in fact, trying to juggle some of the nominations from time to time has been difficult because of the popularity of the races.

Thrilling Brat, with some outstanding performances, captured the three distance group one races and was a very authoritative and popular winner for Gary Harding and Karen Walsh. *Thrilling Brat* has been very good for New Zealand greyhound racing, attracting plenty of interest on both sides of the Tasman with his exploits in Australia in 2012 and attracting a lot of interest in his NZ appearances this year. To be part of the crowd who gave him a standing ovation after his Silver Collar victory was a memorable moment in the sport for me this year.

The remaining eight group one races were shared out evenly, all being won by different dogs, a reflection on the strength of the fields and the evenness of the competitors which made for some extremely exciting racing.


Pretty Good was the leading stake earner in a close finish from *White Air* and *Thrilling Brat,* and in total, seven greyhounds won stakes in excess of \$50,000 and another 60 stakes in excess of \$20,000.

Bright Star and Dixie Lee shared the most wins for the season with 22 each, Dixie Lee getting her wins from just 32 starts.

The sport isn't only about the champions, and without the support of all the owners and trainers, greyhound racing wouldn't be the success it is today, every winner no matter what the grade is an occasion to celebrate.

Venues and communities

Our greyhound clubs successfully ran over 5,200 races this year, 48% of all races held in New Zealand, and in particular Wanganui and Christchurch had a very busy year, with additional races and meetings being held at their tracks. The hard work and planning that go into ensuring that over 99.99% of these races are run on time and without incident is often taken for granted by the sports participants.

While we do have the isolated equipment breakdown, and each and every one of these is taken seriously and investigated, the fact is, day in and day out the race meetings operate very smoothly and successfully. I would like to thank the hard working club officials and volunteers who ensures that

our Licensed Persons raced their dogs in a safe and secure environment this season; you have done a great job!

In October 2012, Wanganui opened their new grandstand to take greyhound racing to a new level in the Central Districts. The new

complex is a great asset both to the community and greyhound racing, and a tribute to the hard work and passion of the Board and members of the club. Most Friday nights the stand is full, and the Wanganui club has made a success of the NZRB Xmas at the Races concept with three Friday Nights scheduled for Xmas 2013.

Integrity

The RIU test a higher percentage of greyhounds for drugs than any other racing jurisdiction in the world they test winners, beaten favourites and also select runners at random, last year over 3,000 greyhounds were tested. Samples are sent to overseas laboratories from time to time to ensure that there aren't any new substances that aren't being detected in NZ.

Despite this rigorous testing the only positives returned over the past few seasons have been at the low end of offending and not deliberate. I am still surprised at the number in our industry who think that some trainers are 'cheating'.

At the forefront of our racing days and nights, making sure racing is fair and the rules are followed, the RIU do an unenviable job with very little thanks, but have played an integral part in the success of our 2012/2013 racing year.





Industry Funding Policy

The Greyhound Industry's Funding Policy for the 2013/2014 racing season comprises a number of different funding streams. These are detailed below:

1. INFRASTRUCTURE, VENUE & TRACK MAINTENANCE

All Clubs, who own, rent or provide a track will be provided with tiered levels of funding to assist them with meeting the costs of track surface and venue maintenance. Clubs must submit a compliance package that includes business plans, financials and budgets before payments are released.

This is based on GRNZ's commitment to maintaining the highest level of integrity.

2. STAKE LEVELS

GRNZ will fund 100% of all clubs' standard minimum stakes.

GRNZ also fund 90% of the Board approved group and feature races.

To support NZ breeding the GRNZ funds breeder bonus payments and the NZ racing series.

Stakeholders are further assisted by \$40 MTA vouchers paid to all non-stakes winning places and no nomination fees are charged.

3. TURNOVER FUNDING

All clubs will receive 16% of all on-course turnover recorded for each race.

They also get paid 5% on FOB sales recorded at the track.



Forecast assumptions

- (1) Based on NZRB actual (July 2013), and 'NZRB Statement of Intent 2013-2016.'
- (2) Existing funding model ends July 2015. New funding model for 2015/16 not yet agreed, therefore assume NZRB income based on current market share.
- (3) Stake payments for races have increased by 5% from 1 August 2013, and growth in future years.
- (4) Costs include Welfare Officer and initiatives proposed by Welfare Review.
- (5) GRNZ has agreement with NZRB to hold 32 extra race meetings in 2013/14 only.

NOTE: Budget for next few years is at a planned 'deficit', however GRNZ has adequate retained earnings to cover this.

action plan 2013 - 2014

The key focus for 2013/2014 will be implementing the recommendations arising from the independent review into Animal Welfare.

- 1. Animal Welfare will have an impact on balance sheet and a new role Animal Welfare officer will be created.
- Raise standard of all tracks to benchmark levels of animal safety.
 - a. Invest in sand/surface research/improvements.
 - b. Introduction of cushion barrier walls.
 - c. Trial/invest in protective flexible running rails.
- 3. Stifle growth in dog numbers:
 - a. Review animal import policy (Introduce fees/restrictions).
 - b. Review the numbers of dogs bred every year.
- c. Introduce education and a managed breeding programme (per Victoria, Australia).

KPI for measuring the success of the implementations will be;

- Reducing the number of greyhounds bred in New Zealand;
- Reducing the numbers of greyhounds never making it to the track;
- · Reducing serious injury numbers;
- Making safety improvements to tracks;
- Safety pads, Steriline safety fence, surface improvements
- Increasing the duration of the average racing life of a greyhound;
- Increasing the number of greyhounds re-homed after their racing career has finished.

As these measures require support from key stakeholders at the GRNZ AGM in October, the Strategic Plan will be updated in early November with specific measurements against the KPI.

(1) Maximise growth of greyhound racing internationally

- Work with NZRB, TABCORP's Sky Racing TV to identify potential export markets – Vietnam, UK, Ireland and Europe develop export plan and strategy.
- Implement approved export plan.
- Pursue strategic partnerships and formal distribution agreements in priority markets.

(2) In conjunction with NZRB actively promote greyhound racing to attract new audiences and participants in New Zealand.

- Develop marketing programme to raise awareness and motivate attendance at race meetings, develop brand.
- In conjunction with clubs and NZRB offer innovative on-course entertainment packages to raise appeal of race meetings.
- Promote GAP and other programmes to raise awareness of greyhounds and highlight strong welfare standards in place for greyhound racing.
- Develop sponsorship and other opportunities to increase awareness amongst general public.

(3) Enhance world class animal welfare practices

- Audit adherence to drug rules in conjunction with the Racing Integrity Unit.
- Develop and enforce over-racing and exploitation policy.
- Design and implement professional development programme for vets.
- Promote responsible breeding programme ensure that greyhound numbers meet racing needs.
- Commission independent annual track reviews.
- Monitor world's best animal welfare practices and incorporate as appropriate.
- Implement a plan that encompasses implementing review recommendations, appoint Welfare Manager to oversee plan.



Greyhound Racing New Zealand (GRNZ) is the trade name of the New Zealand Greyhound Racing Association (NZGRA or The Association). The GRNZ is an incorporated society consisting of the ten registered member greyhound racing clubs throughout New Zealand.

The GRNZ and its ten clubs are recognised in the Racing Act 2003 as a constituent part of the New Zealand racing industry.

The racing industry is governed by the New Zealand Racing Board (NZRB) in accordance with the Racing Act 2003. The NZRB is required to provide governance and oversight to the industry and the GRNZ through approval of the annual GRNZ statement of intent and business plan.

Role of the GRNZ Board

The Board is responsible for setting the strategic direction of GRNZ in accordance with its ultimate responsibility, that being to promote and advance greyhound racing, registration, breeding, safety and welfare in New Zealand.

The Board takes a disciplined commercial approach to its role which includes reviewing and approving the Statement of Intent and annual Business Plan, approving major infrastructure decisions and club investments, monitoring the financial performance of the Association, appointing and reviewing the performance of the General Manager and ensuring the integrity of governance and greyhound advocacy at an industry and political level.

The Board has delegated some of its powers to Committees of the Board, and the day-to-day management of the Association to the General Manager and Management. These delegations are summarised in a Governance Charter (which documents the terms of reference of each Committee and the Association's Delegations Policy to the General Manager) and by relevant minuted meetings and resolutions of the Board.

Board committees

The Board has six formally constituted committees, these being - the Racing Committee, the Dates Committee, the Finance Committee, the Integrity Committee, the Animal Welfare Committee and the Personnel and Remuneration Committee.

A brief overview of the matters dealt with during the year is as follows:

Racing Committee

CHAIRED BY GRAEME CALVERLY

The Committee met in advance of each respective Board meeting to discuss and review various racing and rule specific matters on behalf of the Board.

Dates Committee

CHAIRED BY JOHN APANOWICZ

The Dates Committee met during the year in conjunction with the NZRB process to establish licence allocations to clubs for the 2012/2013 season.

Finance Committee

CHAIRED BY KHOA NGUYEN

The Finance Committee met on an as-required basis and was responsible for advising the Board on the financial policies and the financial position of GRNZ.

The Committee developed and reviewed the stake level changes and the draft funding policy to the clubs as prepared by Management. The Board approved the updated funding policy once clarity of the updated NZRB funding had been received. In addition the Committee reviewed and recommended the 2012/13 operating and capital budgets for adoption.

Personnel & Remuneration Committee

CHAIRED BY MAURO BARSI

The Committee during the year advised the Board on the process of reviewing the General Manager's performance and remuneration, including the performance incentive arrangements.

Integrity Committee

CHAIRED BY MAURO BARSI

The Integrity Committee reviewed matters relating to our judicial rules, individual Licence Person registration applications, and other matters of integrity for the Code. The Committee reviews approaches proposed by Management in relation to integrity matters.

Animal Welfare

CHAIRED BY PHIL GREEN

The committee has been charged with ensuring that "All greyhounds in New Zealand are protected and promoted by the adoption and development of sound animal welfare standards and practices."

The committee reviews all matters relating to animal welfare across all aspects of the industry.

Conflicts of interest

Where any GRNZ director has a conflict of interest, or is otherwise interested in any transaction, that director is required to disclose his or her conflict of interest and there after will generally not normally be able to vote in relation to the relevant matter. The Association maintains disclosure of interests declared in its minutes.

Each of the racing members of the Board has potential conflicts of interest by virtue of their appointments process and the stakeholders of their constituency. These potential conflicts are all known around the Board table and the Board has taken the approach that each member can speak to, and on behalf of a specific club on general code issues. Specific club matters or requests to the Board are required to be put in writing through Management.

All greyhounds in New Zealand are protected and promoted by the adoption and development of sound animal welfare standards and practices.

Industry Relationships

The continuing functional relationship between GRNZ and the NZRB operates well with Mauro Barsi acting as our code representative.

The Board has a policy of active participation in Greyhounds Australasia with Mr Jim Leach attending GA Board meetings on a regular basis.

A future for racing dogs

We are proud to announce our plan for the health and well-being of our dogs.

The Racing Dog Welfare Programme consists of eleven components that improve monitoring and tracking of all dogs from birth, and enforce and clarify rules about dog welfare. It also clarifies how we will reduce the number of dogs that need to be euthanised.

Our sport loves its dogs. The Independent Review found that we have no major welfare issues at all.

But it has said we must get much better at guarding welfare using rules, rather than relying only on the good intentions of people in the industry.

It said the wider community expects the industry, not just its individual members, to show clearer commitment to welfare.

So we've developed the Racing Dog Welfare programme – a set of rules, guidelines and funding that ensures our dogs are raced humanely. You will be proud to talk to others about this programme.

Why we have a scheme

The Racing Dog Welfare Programme is the culmination of various efforts to do best by the dogs at the heart of our sport.

We have relied on each other to love and care for our dogs, and our faith has been well placed. There have been no prosecutions of our members for mistreatment of racing greyhounds.

The Board's Welfare Committee has been dealing with practical matters as they arise, such as regular kennel checks, race day checks by vets, and our growing sponsorship of the GAP rehoming project.

A modern sport needs good intentions to be backed with good clear rules and close management. Some in society want to find fault and point fingers. Our lack of transparency and absence of systems gives activists grounds to claim the worst, and gives the well-intentioned public no reason to disbelieve them.

So, in November 2012, GRNZ commissioned an independent review of the management of greyhound welfare. The Review team reported back in June 2013.

The team concluded that there is no current welfare problem; that our greyhounds are well cared for. It was however, disappointing to find that this was really due to the dedication and good will of our people, rather than meticulous planning. It said we should therefore place formal emphasis on welfare, and meticulously track and monitor dogs from the start of their life, until retiring and re-homing - and stringently apply rules for their welfare.



The Programme summary

DAILY HEALTH

1. Appoint a Welfare Officer

- To ensure dog tracking processes are adhered to by everyone.
- · To run all dog health checks.
- To apply a specific welfare code.

2. Welfare code

 A set of standards covering conditions in which greyhounds are kept (enshrining the common practice on kennel and travel facilities size, similar to the Australian model).

BREEDING

3. Register breeders, increase breeding fees and require training

What the review said

CARE AND WELFARE OF RACING GREYHOUNDS

There are no issues relating to the care of greyhounds during their racing careers; owners and trainers are committed to the welfare and safety of their dogs and care passionately about them throughout their lives.

There has never been a conviction of a Licenced Person under the Animal Welfare Act.

There are no formal minimum standards of welfare in place that have been approved by any external welfare bodies, and there is both a lack of enforcement, and awareness of welfare standards.

POPULATION MANAGEMENT

Lack of effective reporting means it is unknown what happens to many greyhounds.

Approximately 200 greyhounds each year do not make it to the race track

30% of the 2,305 greyhounds leaving racing between 2009 and 2012 are recorded as deceased but the potential is higher.

The issue of euthanasia of healthy greyhounds is a concern given changes in community expectations on animal welfare.

TRACK SAFETY STANDARDS AND INJURIES.

Concerned by the incidence of injuries occurring during racing.

The practice of recording and monitoring injuries in NZ is inadequate.

Note: there is now a system to identify the nature of injuries and the specific likely cause, such as racing collision or track surface.

There is no reference or international standard on possible injury-causing factors such as optimum track surface, the optimum bend camber, distance of starting boxes to turns, and the ideal number of turns on a track.

Consequently management of track issues will continue to be point of conflict until best practices are researched and documented.

The introduction of standards for moisture content and compaction readings for each track in New Zealand is a first step to establish measurable benchmarks.

GOVERNANCE AND MANAGEMENT OF WELFARE

A number of welfare actions have been initiated by GRNZ. However, the GRNZ Board has not prioritised actions or commitment to the goal to have 'world class' welfare.

The creation of a welfare committee and the instigation of this review reflect an increased awareness and commitment by the GRNZ Board to address the gaps.

There is a culture of non-enforcement and non compliance of welfare rules.

GRNZ should lead a cultural change within the industry, to ensure welfare considerations outweigh any competitive or commercial consequences.

CORE REVIEW RECOMMENDATIONS

- Education programs in breeding to manage the number of greyhounds whelped.
- Alternative racing programs to accommodate a greater range of dogs.
- Transparency and awareness of the tracking of the life-cycle of the greyhounds with improved database management and monitoring.
- Development of improved injury reporting.
- Development of formalised and contemporary welfare standards.
- Better enforcement of the current rules with regards to the retirement of the greyhound.
- A review of the service agreement with RIU.
- A review of the retirement options for greyhounds when not racing.
- A funding commitment by participants and industry to achieve better retirement outcomes.

Auckland Greyhound Racing Club

Long standing club with purpose built, stand alone venue. The first club in New Zealand to install a sand/loam racing surface. Hosts a number of the code's flagship races including the Auckland Cup and the time honoured Duke of Edinburgh Silver Collar.

Waikato & Districts Greyhound Racing Club

Shares its dual code racing venue at Cambridge Raceway with the Harness code. Provides a big, sweeping, one-turn track configuration, renowned for producing the country's fastest race times. Home of the NZ Derby, a classic event for restricted age greyhounds.

Wanganui Greyhound Racing Club

Another of the code's stand alone racing venues, Hatrick Raceway has recently been the 'pulse' of greyhound racing in the Central Districts region, hosting in excess of 90 race meetings each season. A tight circuit combined with a fast racing surface contribute to all-action race viewing, both on course and via Trackside. The club hosts such significant events as the NZ Breeder's Stakes, the Wanganui Distance and the Spion Rose.

Palmerston North Greyhounds

Located at Manawatu Raceway, a facility shared with the local Harness Club. It provides a big, roomy, one-turn track ideal for strong greyhounds. The license is held by Wanganui GRC as an interim arrangement until a new club is established.

Christchurch Greyhound Racing Club

The largest club in the country, the Christchurch club's base (shared with Harness) at Addington Raceway is an excellent facility for participants and enthusiasts alike and plays host to a number of the code's glamour events such as the NZ Cup, the NZ Oaks and the Kingston Cup. It is often said that it takes a 'strong greyhound' to win at Addington.

Otago Greyhound Racing Club

Located at one of the country's oldest racing venues, Forbury Park, the club provides a real community feel to its racing product. Consistently providing one of the code's best racing surfaces, the club frequently plays host to visitors bringing their charges to race from both North (Canterbury) and South (Southland).

Southland Greyhound Racing Club

Situated at Ascot Park, the only tri-code (all three racing codes) venue in New Zealand. The track provides all greyhounds competing with an 'even chance at the spoils' and the surface itself, with the beautiful sand sourced from a nearby beach, is very 'kind' to all competing greyhounds. Another club with a real emphasis on 'local flavour' and encouragement in participation.

Tokoroa Greyhound Racing Club

Mossop Road is the home of the Tokoroa Greyhound Racing Club. No totalisator race meetings are held at this venue but the club conducts one race meeting annually which is hosted at Cambridge Raceway. The rural based club has long been a production line for breeding, trialling and training of quality greyhounds.

Taranaki Greyhound Racing Club

Burnside Showgrounds is the home of the Taranaki Greyhound Racing Club. Taranaki is one of the oldest Greyhound racing clubs in New Zealand. No totalisator race meetings are held at this venue with the club conducting an annual two day Easter picnic meeting. Taranaki also run a totalisator race meeting at Wanganui. The rural based club has also long been a production line for breeding, trialling and training of quality greyhounds.

Ashburton County Greyhound Racing Club

Chertsey Domain is the home of the Ashburton County Greyhound Racing Club. No totalisator race meetings are held at this venue but the club conducts one race meeting annually which is hosted at Addington Raceway. The rural based club has also long been a production line for breeding, trialling and training of quality greyhounds.

Wellington Greyhound Racing Club

The Wellington Greyhound Racing Club has a proud history with the first non-tote racing meeting held at Hutt Park Raceway on Saturday 28 August 1976. The first race was won by Bluey & Curly for prize money of \$25. While Hutt Park Raceway no longer exists the club remains dedicated to greyhound racing. The club conducts a small number of race meetings which are run at Hatrick Raceway, Wanganui.







GREYHOUNDS AS PETS Kerry Marshall, Chair, GAP Trust

Since GAP was created seven years ago we will have retired nearly 1000 dogs as pets.

Greyhounds as Pets has had an interesting year.

Our focus, of course, is homing greyhounds which are no longer suitable for racing. It is our mission, and each year we have increased the number of dogs adopted as pets.

Since GAP was created seven years ago we will have retired nearly 1,000 dogs as pets.

We have introduced these wonderful pets to hundreds of owners throughout New Zealand. Greyhounds being led around suburban footpaths as much loved pets, are a common sight these days.

This year saw further changes to the GAP structure. It became clear that the move to operate the Trust from the South Island was not working as we had hoped. Also the Amberley kennels were closed to GAP. Accordingly we returned the core base operation to Petone, in the lower North Island - closer to Greyhound Racing New Zealand (GRNZ). We were then fortunate enough to re-employ our original programme director, Jacqui Eyley, who returned to us after a brief sojourn in the commercial sector.

Last year I indicated that we wished to expand our kennel network, as our current kennel model, which is working well, is still potentially vulnerable. We continue to have discussions with GRNZ in regards to this, and it is still a work in progress.

As mentioned last year, we have a stunning network of supporters who continue to help GAP achieve successful outcomes. I want to thank the trainers and owners, the regional and area co-ordinators, the fundraisers and donors, the foster home folk and the home checkers, the vets and the kennel owners, the GRNZ Board and staff and the GAP Board and staff, who have been singularly driven to provide homes for retired racing greyhounds.

The Network is in good heart under Jacqui's management and I am confident that with increased awareness in our communities, Greyhounds as Pets has an exciting future.

GREYHOUNDS AS PETS Jacqui Eyley, Programme Director

The highlight of the year has been the placement of television and radio commercials, created by Saatchi & Saatchi, on community filler lists.

Overview

The programme's success continues with adoption numbers steadily increasing. Pet greyhounds are now becoming a frequent sight in the community, and with nearly 1,000 greyhounds successfully re-homed, many people either know of someone with a pet greyhound, or are at least aware that greyhounds make good pets.

This year has been a challenging one for the Trust with increasing adoption numbers putting pressure on resources. In particular, the increasing number of dogs being adopted to homes in the Auckland region put pressure on existing transport arrangements. Fortunately Greyhound Racing NZ helped us improve logistics with additional funding for transport and kennelling.

The year also saw several changes of personnel with Glenstar Kennels taking over as our South Island kennel base, the addition of subsidiary kennel facilities at Shannon and changes in two of the four Regional Co-ordinator roles.

This period of change has emphasised the risks facing the programme and confirmed the need for a third kennel base in the north of the country.

Overall however, the changes have been mostly positive, and with additional funding from GRNZ, the Trust is now able to grow into a stronger entity with an exciting future.

Promotion

GAP supporters have attended an increasing number of dog-friendly events around the country, including many A&P shows, lifestyle and pet expos, street fairs and galas. We are finding an increasing proportion of adoption applications are coming from areas into which a significant number of greyhounds have already been adopted. Our focus therefore is still on identifying opportunities where people can meet a greyhound and learn about the breed from people who are already smitten! To achieve this we are working with Animates on regular Adopt A Greyhound Days', and encouraging fund-raising events at supermarkets.

The highlight of the year has been the placement of television and radio commercials, created by Saatchi & Saatchi, on community filler lists. The combined airtime over the December to January period was valued at over \$500,000 and the advertisements are still being played today. This type of media advertising is generally outside of the Trust's budget and confirms that building relationships with supporters can be hugely beneficial as well as enjoyable.

This year saw the development of a new website and customer relationship management software with online application forms and improved integration with social media, Facebook and our new email newsletter, 'Hounding Around' which launched in November 2012, have become valuable tools, helping increase awareness and encouraging involvement.



Relationship with the racing industry

The programme's relationship with GRNZ was strengthened this year with the appointment of the Chair of GRNZ's Welfare Committee to the GAP Board. Phil Green provides valuable knowledge and experience to the Board and acts as a point of contact for both Boards on strategic direction and funding.

The programme continues to have good support from many racing owners and trainers. Users have expressed a preference for a flexible approach towards the waiting list, allowing trainers to submit entry forms for dogs early in their career and swap places between dogs entered by the same person. However, this is under regular review as we strive to ensure the waiting list works equally well for all users.

Financial summary

Funding from industry increased to \$176,000 this year, including the much needed additional grant for kennelling and logistics. Meanwhile donations from private individuals rose to over \$80,000, including nearly \$20,000 from two annual street appeals held in April 2012 and March 2013. The programme's regular donation scheme, Steadfast Friends, continues to expand with \$24,640 donated in this financial year, up 12% on the previous year. These donations are absolutely essential for covering our daily kennelling costs and additional veterinary treatment. Profit from the GAP shop was slightly lower at just over \$15,000.

Shop profit increased following the launch of the new online shop in January 2013. The online shop now also accepts credit cards. Community grants are proving difficult to obtain with just \$6,560 approved.

At the end of the year, assets held by the Trust had increased by \$23,421 to total \$140,023, including \$95,000 in cash. The Trust is holding these reserves as a deposit on a future purchase of a GAP owned kennel base.

Planning for the future

The GAP Trust is working with GRNZ to reduce the numbers of greyhounds euthanised at the end of their racing careers. The racing industry is looking into ways in which the dogs' useful racing lives can be extended and researching alternative careers for them post racing. This means the adoption of Greyhounds as Pets is an increasingly important part of the industry's welfare strategy, and we are working towards a realistic goal of 350 adoptions each year.

In the short term, to achieve this objective, we will need to establish a third kennel base in the north to improve access for prospective adopters, and allow our team to focus on promotion and adoption rather than logistics. There is great potential to increase the number of adoptions in the Waikato and Bay of Plenty region and the establishment of a kennel base here will help boost numbers in this region and further north.

In the long term, the Board firmly believes that the purchase of either an industry or GAP owned kennel base is essential to ensure the stability and longevity of the GAP programme.

The future is looking bright for greyhounds. The breed is becoming well known for its gentle, affectionate and lazy nature attributes which make it an ideal pet for today's busy lifestyles. We look forward to working with GRNZ and our supporters, to find more homes for greyhounds when their racing careers have ended.

The Board would like to thank Greyhound Racing New Zealand and all our supporters and donors for helping greyhounds find a new home after racing.






