TAB GREYHOUND PUNTER OF THE YEAR ("THE COMPETITION") TERMS AND CONDITIONS

1. All individual entrants must have a verified TAB NZ betting account, and the principal member of each team must have a verified TAB NZ betting account. For collects of \$1,000 or more, a verified TAB NZ account number must be provided.
2. Employees of the Auckland Greyhound Racing Club and any persons under the age of 18 are not eligible to enter the Competition.
3. Entrants (including all team members) must be on-course at Manukau Stadium on Sunday 28 January 2024 in order to enter the Competition.
4. The cost to enter the Competition is \$500, which entitles the entrant/team to a \$500 betting voucher for the Competition, lunch and drink vouchers.
5. A person may enter as an individual or as a team comprising a maximum of four people. A team must have a principal member to whom any winnings will be paid. The make-up and shares of any syndicate are the responsibility of the principal syndicate member.
6. A person may enter the Competition as both an individual and as a member of a maximum of one team, provided that both entries are accompanied by the \$500 entrance fee.
7. Names of contestants will be disclosed, although a nom de plume may be used for publicity purposes.
8. Registrations must be received by the Auckland Greyhound Racing Club before 6pm Friday 26 January 2024. The Auckland Greyhound Racing Club reserves the right to cancel the Competition if fewer than 20 registrations are received.
9. The \$500 entrance fees must be received by the Auckland Greyhound Racing Club before 6pm Friday 26 January 2024, unless special arrangements have been made with the Club.
10. Each betting transaction must start and finish with a deposit betting voucher. Failure to do so may result in disqualification.
11. The Competition will be run across Races 2-12 at the Auckland GRC meeting on Sunday 28 January 2024. Races at other venues are not included in the Competition.
12. A minimum of \$50 must be invested on each of Races 2-12 at the Auckland GRC meeting, or the balance of the voucher if the balance is less than \$50.
13. A contestant will not be disqualified if their entire balance is held up due to an inquiry. If part of their balance is held up due to an inquiry, the minimum investment rule still applies.
14. It is the contestant's responsibility to ensure their investments are placed on time. No claims for incorrect or lost tickets will be considered as part of the competition.
15. The onus to check tickets remains with the contestants, and it is therefore strongly recommended that entrants fill out betting slips to place their bets.
16. Pick 6, Place 6, Doubles, Trebles, Quaddies, Pokers, Multis and All-Ups cannot be taken as part of the Competition. For the avoidance of doubt, individual Fixed Odds bets are allowed.
17. First place of the Competition will be the individual or team who has achieved the highest profit after dividends have been paid out on all races at Manukau. Second place of the Competition will be the individual or team who has achieved the second highest profit after dividends have been paid out on all races at Manukau. Third place of the Competition will be the individual or team who has achieved the third highest profit after dividends have been paid out on all races at Manukau.
18. The winner of the highest turnover prize will be the individual or team who turned over the highest amount of money in total across Races 2-12.
19. In the event of a tie for any of the prizes, the prizes will be shared equally between tied contestants.
20. The decision on all placegetters and highest turnover prize winner shall be determined by the Auckland Greyhound Racing Club. This decision shall be final and no correspondence will be entered into.
21. Any entrant who does not adhere to any of these Terms and Conditions may be disqualified.
22. If, for any reason, the race meeting is postponed or cancelled, the winner and placegetters shall be determined by betting voucher balance at the time the meeting is stopped on the day, and the highest turnover winner shall also be determined at the time the meeting is stopped.
23. If the race meeting is abandoned prior to Race 7, only half of the total prize pool will be paid out. If the race meeting is abandoned after Race 7, the full prize pool will be paid out.
24. If the race meeting is abandoned prior to Race 2, all entrants shall be entitled to a refund of their entrance fee.
25. The Auckland Greyhound Racing Club shall be the sole judge of the application of the Terms and Conditions for the Competition, and after giving the opportunity to any disaffected or interested party to make any submission, the Club's decision in regard to the matter shall be determinative and no further correspondence or communication shall be entered into.

THE RULES

1. Registrations must be received by the Auckland Greyhound Racing Club before 6pm Friday 26 January 2024.
2. Payment of \$500 must be received by the Auckland Greyhound Racing Club before 6pm Friday 26 January 2024, unless special arrangements have been made with the Club.
3. Entrants (including all team members) must be on-course at Manukau Stadium on Sunday 28 January 2024 in order to enter the Competition.
4. All entrants will be given their betting vouchers at the commencement of the day following identification.
5. At the end of the day, the TAB software will trace all transactions made against each entrant's starting betting voucher, which will determine the prize winners.
