

# New Import / Greyhound Returning to NZ

**Process to be completed by any licensed person bringing a greyhound/s into New Zealand, regardless of whether the greyhound is to race or not.**

Approval is not guaranteed; all approvals are at the sole discretion of Greyhound Racing New Zealand (GRNZ).

Once approval has been granted, a Transfer of Ownership from the Australian owner to the New Zealand owner is required (complete Transfer of Greyhound Ownership form).

A MAXIMUM of 20 permits per month can be approved - a maximum of five permits per **training facility** per month.

**PLEASE READ below before completing form.**

1. Approval is required **before** any arrangements for transportation of a greyhound into NZ can be made. Any greyhound shipped without prior approval **cannot** be registered for racing.
2. Failure to submit all application documents may delay the processing time. We recommend applying as soon as possible, and please write clearly.
3. Once this form is submitted, you will receive approval within 7 working days for the greyhound to be shipped within the allocated month.
4. Shipping documentation with **proof of date of import** must be provided to finalise the permit. On receipt of this proof of import, the invoice will be sent to you and the administration fee will be due **20<sup>th</sup> of the month or before the greyhound's first race in NZ**, whichever is sooner.
5. If the administration fee **has not been paid by the 20<sup>th</sup> of the month** following the invoice, a credit note will be issued and the allocated slot will be opened to other members wishing to import a greyhound. This will result in a new application having to be completed.
