- Greyhound Racing New Zealand (GRNZ) licences must be renewed annually.
- **If your licence has lapsed for over two months, you will need to re-apply for a new licence.**
- Processing your licence cannot be finalised until payment has been received and your completed renewal form has been approved by the Head of Racing. Your licence card will then be sent out.
- Refunds are not given. When upgrading a licence e.g. Owner Trainer to Public Trainer, the licence fee will be calculated pro-rata for the remainder of the season from the date of approval of the new licence.
